1. Submission of application and compliance to the applicable norms and eligibility criteria shall not be deemed as approval to the Assayer unless explicitly conveyed by the ICCL. Additionally, ICCL also reserves the right to modify/ amend/ upgrade some of the requirements from time to time.
2. On receipt of the documents, ICCL shall review such submission and wherever deviations/ shortfalls are observed, shall call upon the Assayer for submission of additional information/ declaration until compliance to the requisite standards.
3. Thereafter, the same shall be referred to the Membership Selection Committee of ICCL. The Committee reserves the right to call for more information as well as have discussions with any applicant/s and seek clarification on any issue as may be required by it. The Committee may also seek additional undertaking from the Assayer. ICCL's decision in this regard will be final.
4. Selected applicant will be issued in-principle approval subject to conditions specified therein.
5. The compliance of terms and conditions laid down by ICCL/BSE is an essential condition of grant of approval.
6. Assayer will be bound by all the directives issued by the Regulator, BSE and ICCL from time to time.
